


### **Energy Assistance**

Energy Assistance is still accepting applications through May 14th. Maybe you or someone you know always pays their electric or gas bill on time but may struggle with other expenses; help on the utilities could free up money for those expenses. Do you have retired parents with limited income that haven't heard of the program? We will gladly send them an application, just email us their address. You can also check out our website at www.hoosieruplands.org for information on how to apply. It is really easy and applications are kept confidential.

For those of you that may be unfamiliar with the program, the Low-Income Home Energy Assistance Program (LIHEAP) is a federally funded Block grant offered through the U.S. Department of Health and Human Services (HHS). The LIHEAP Block Grant funds individual states to assist low-income families with the high cost of their home energy. Since July 1, 2006, the block grant has been administered by the Indiana Housing and Community Development Authority (IHCDA). In Indiana, this program is known as the Energy Assistance Program (EAP). Hoosier Uplands administers this program in Lawrence, Martin, Orange and Washington Counties. For program questions, please contact:

#### **Indiana Emergency Rental Assistance**

The Indiana Emergency Rental Assistance (IERA) program is designed to decrease evictions, increase housing stability, and prevent homelessness by helping renter households whose income has been negatively impacted by COVID-19 with rent and utility assistance.

IERA can provide you with up to 12 months of rental assistance. Qualifying applicants may also receive utility and/or home energy assistance. This includes help with paying past due utilities (electric, gas, water, sewer, and trash) and home energy (fuel oil, wood, coal, pellets, and propane) expenses along with internet assistance for past due expenses.

### **Creating Lasting Family Connections**

Creating Lasting Family Connections is a new program that is designed for any family seeking to improve communication, increase emotional health, or become educated about substance abuse prevention. The program will consist of five modules: Getting Real, Raising Resilient Youth, Developing Independence and Responsibility, Developing Positive Parental Influences, and Developing a Positive Response.

The program consists of two separate classes. One class will consist of parents or guardians, and the other will be for youth 9-19 years of age. The youth will be separated into groups based on their age, to ensure they will be a part of age appropriate conversations. A free meal will be provided for all participants before the class begins. Families will be able to receive a \$50.00 gift card after completing the program.

The program will be over 10 weeks, with two sessions each week. We will meet Mondays and Wednesdays from 5:00 p.m.-7:30 p.m., and the sessions will be held in the Stone Gate building in Bedford, Indiana. The first cohort is projected to meet in May of 2021.

There will be a virtual programming option for those concerned about COVID-19. However, we do encourage participants to participate in person if they are able. All COVID-19 restrictions will be followed through the program.

### **Client Assistance Programs**

Hoosier Uplands has received Community Services Block Grant funding from the CARES act for a variety of services to help those in need through the COVID-19 pandemic. One way that this funding will be used at Hoosier Uplands is to help clients with emergent needs to get back on their feet. If you have a client who is struggling through the pandemic due to job loss or another financial strain due to COVID-19, they may qualify for this program. Clients must be at or below 200% of the federal poverty level and may qualify for up to \$1,500. Similar funding is available through funding that Hoosier Uplands has received from the Lawrence County Community Foundation that is just for Lawrence County residents. Funding for both projects is limited, but please reach out to one of those listed below if you have questions about the program or have a client in need.
